Summary of proceedings of the 63rd Annual General Meeting (AGM)

The 63rd Annual General Meeting ('AGM') of the members of Dai-ichi Karkaria Limited was held on Friday, September 22, 2023 at 11:30 a.m. (IST) via Video Conferencing/Other Audio Visual Means ("VC/OAVM") facility. The Company, while conducting the Meeting, adhered to the circulars issued by the Ministry of Corporate Affairs ('MCA') in compliance with the provisions of the Companies Act, 2013 ('Act') and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations').

Mrs. Shernaz Vakil chaired the Meeting. The requisite quorum being present, the Chairperson called the Meeting to order. The Registers as required under the Companies Act, 2013 were available for inspection. Since there was no physical attendance of Members and in compliance with the Circulars issued by MCA and Listing Regulations, the requirement of appointing proxies was not applicable, except for the authorized representatives of Corporate shareholders.

The shareholders were introduced with the Directors present at the 63rd AGM. Mr. Farokh Gandhi, Chief Financial Officer and Mr. Ankit Shah, Company Secretary also joined the AGM from the registered office of the Company.

The representatives of Statutory Auditors, B S R & Co. LLP and Secretarial Auditors, Vinod Kothari & Company, also joined the meeting through Video Conference. Vinod Kothari & Company, Practicing Company Secretaries were appointed as the scrutinizer by the Board for scrutinizing the votes cast at the meeting and through remote e-voting. The representative of the scrutinizer was present at the meeting.

The Chairperson then delivered her brief speech to the shareholders.

With the consent of the Members, the Notice of the AGM dated August 11, 2023, circulated to all the members, was taken as read. The Members were informed that the Statutory Auditors' Report on Standalone and Consolidated Financial statements and Secretarial Audit Report for the year ended March 31, 2023, did not have any qualification/observation.

The following items of business, as per the notice of the AGM dated August 11, 2023, were transacted:

- 1. Ordinary Resolution- To receive, consider and adopt:
 - a) the Audited Standalone Financial Statements of the Company for the Financial Year ended March 31, 2023 and the Reports of Board of Directors and Auditors thereon; and
 - b) the Audited Consolidated Financial Statements of the Company for the Financial Year ended March 31, 2023 and the Report of the Auditors thereon.
- 2. **Ordinary Resolution-** To declare a dividend of Rs. 4 per equity share of Rs. 10/- each for the financial year ended March 31, 2023.



- 3. **Ordinary Resolution** To appoint a Director in place of Mrs. Shernaz Vakil (DIN:00002519), who retires by rotation and being eligible, offers herself for re-appointment.
- 4. **Ordinary Resolution** To ratify remuneration payable to M/s. Diwanji & Associates, Cost Accountants, (Firm Registration no. 100227) appointed as Cost Auditor of the Company, amounting to Rs. 1,50,000/- plus applicable taxes and reimbursement of actual out of pocket expenses incurred in connection with the Cost Audit of the Company, for the financial year ending March 31, 2024.
- 5. **Ordinary Resolution-** To approve Material Related Party Transactions for Sale of Goods to ChampionX Dai-ichi India Private Limited upto maximum aggregate value of Rs. 50 crores at arm's length basis and in the ordinary course of business.
- 6. **Special Resolution** To appoint Mr. Cyrus Bagwadia (DIN: 01565989) as an Independent Director of the Company for a period of five years commencing from August 11, 2023 till August 10, 2028, not liable to retire by rotation.
- 7. **Special Resolution** To appoint Mr. Behram Sorabji (DIN: 02035239) as an Independent Director of the Company for a period of five years commencing from August 11, 2023 till August 10, 2028, not liable to retire by rotation.

The Chairperson then invited the Members to express their views, ask questions and seek clarifications on the operations and financial performance of the Company and on the resolutions set out in the Notice of 63rd AGM. The Members were given an opportunity to speak in the order in which they had registered their names. After giving sufficient time to all Members who wished to speak, the Chairperson appropriately responded to queries raised by them.

The Chairperson informed that Members who have not casted their vote through remote e-voting are requested to cast their vote through e-voting on their respective demat platforms maintained with the depositories, which will be available for the next 15 minutes, which shall be the conclusion time of the 63rd AGM.

Results on remote e-voting and e-voting during the 63rd AGM will be disclosed within two working days from the conclusion of the AGM on the website of Company, CDSL and BSE.

Thereafter the Chairperson thanked all for attending the Meeting and declared the Meeting to be concluded. The Meeting ended at 12:50 p.m.



The Consolidated Scrutinizer's Report was received after conclusion of the Meeting on September 22, 2023. All the Resolutions were declared as passed with requisite majority.

Sub: Consolidated Scrutinizer's Report on remote e-voting and e-voting carried out, pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 for the 63rd Annual General Meeting ("AGM") of the Equity shareholders of Dai-ichi Karkaria Limited ("Company") held on Friday, 22nd September, 2023 at 11:30 a.m. through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM").

Dear Madam.

- 1. I, Vinita Nair, Senior Partner of Vinod Kothari & Company, Practicing Company Secretaries, (Membership No. FCS 10559/ C.P. No. 11902) have been appointed as the Scrutinizer by the Board of Directors of the Company at its meeting held on August 11, 2023 for the purpose of scrutinizing the remote e-voting prior to the AGM and e-voting during the AGM, pursuant to the Notice dated August 11, 2023 issued under Section 96, Section 108 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act") (including any statutory modification or re-enactment thereof for the time being in force) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 ("Rules"), as amended from time to time, read with General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 20/2020 dated May 05, 2020 and other relevant circulars, including General Circular No. 10/2022 dated December 28, 2022 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars") and as per Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force), to transact the following ordinary and special businesses as contained in the Notice of the AGM.
- 2. In terms of Regulation 44 of the Listing Regulations and pursuant to Section 108 of the Act read with Rule 20 of the Rules in connection with all resolutions proposed at the 63rd AGM, the Company has availed services of Central Depository Services (India) Limited ("CDSL") and provided remote e-voting facility prior to the AGM and e-voting facility during the AGM to the equity shareholders

- of the Company who could not vote earlier through remote e-voting facility provided by the Company.
- 3. The Notice dated August 11, 2023 along with statement setting out material facts under Section 102 of the Act in respect of the businesses mentioned in the notice, as confirmed by the Company, was sent via email to the Members whose e-mail addresses were available with the Company, RTA and Depositories.
- 4. The shareholders of the Company holding shares as on Friday, September 15, 2023 ("Cut-off Date") were entitled to vote on the businesses as contained in the Notice. The voting period for remote e-voting commenced on Tuesday, September 19, 2023 at 9 a.m. IST and ended on Thursday, September 21, 2023 at 5 p.m. IST and the CDSL remote e-voting module was disabled thereafter. The CDSL e-voting platform was re-opened during the AGM for those members who had not cast their votes on the businesses as contained in the Notice through remote e-voting and kept open for 15 minutes after the AGM. The votes cast under remote e-voting facility and e-voting during the AGM were thereafter unblocked in the presence of two witnesses, *viz.*, Ms. Aisha Begum Ansari and Mr. Kaushal Shah, being Senior Manager and Executive of Vinod Kothari & Company, Practicing Company Secretaries. These witnesses are not in the employment of the Company.
- 5. I have scrutinized and reviewed the votes cast through remote e-voting and e-voting during the AGM based on the data downloaded from the CDSL e-voting system and have maintained a register in which necessary entries have been made in accordance with the Rules, as amended.
