 Foreign Investment or Collaborators, if any: In the oil field sector, the Company has tied up with a major U.S. based Oil Field Chemical Company, CTI Chemicals which is 100% subsidiary of ChampionX Corporation (Delaware) and has formed a Joint Venture Company, ChampionX Dai-ichi India Private Limited.

II) Information about the appointee:

Ms. Meher Vakil:

- 1. **Background Details:** Ms. Meher Vakil, 37 years, is currently the Whole-time Director and Chief Operating Officer of the Company and Member of Stakeholders Relationship Committee of the Company. She has been associated with the Company for the last 7 years.
 - Ms. Meher Vakil has a Bachelor of Arts in Economics and Business Institutions from Northwestern University, Illinois, USA and has significant experience in Marketing and Business Development.
- **2. Past remuneration:** During the current financial year 2022-23, Ms. Meher Vakil was paid: Salary: Rs. 79.35 lakhs, Perguisites: Rs. 52.74 lakhs and Performance incentive: Rs. 20 lakhs.
- 3. Recognition or awards: Ms. Meher Vakil is well recognized for enhancing efficiencies in departments such as Marketing, Sales, IT, Finance, HR and production, and is actively involved in designing and implementing business strategies, as well as establishing policies that promote company culture with a vision to drive extensive and sustainable growth. Ms. Meher Vakil has been a director at multiple New York based companies, focusing specifically on Marketing & Sales, Business Operations Strategy, and Technology Innovation.
- **4. Job profile and her suitability:** Ms. Meher Vakil is a young entrepreneur with rich managerial experience to drive the future growth of the Company through innovation and an enterprising long term sales strategy. Her contribution in managing the business affairs of the Company is significant.

5. Remuneration proposed: The Board of Directors of the Company at its meeting held on February 10, 2023 approved the terms of remuneration for the period from 1st April, 2023 to 31st March, 2026 as under:

a. Salary:

The Basic salary proposed is Rs. 9,25,750 (Rupees Nine Lakh Twenty-Five Thousand Seven Hundred Fifty only) per month for F.Y 2023-24 and with annual increments of 15% for F.Y. 2024-25 and F.Y. 2025-26 respectively, subject to annual review of the Nomination and Remuneration Committee and the Board, keeping in view of Company's performance.

b. Perquisites & Allowances:

The terms and conditions during the currency of her tenure of three years as Managing Director may be altered or varied by the Board of Directors on recommendation of the Nomination and Remuneration Committee, as it may deem fit and as may be permissible in accordance with the provisions of Schedule V to the Companies Act, 2013 read with Sections 196 and 197 to the Companies Act, 2013.

Ms. Meher Vakil will not be paid any sitting fees for attending the meeting of the Board of Directors of the Company or any Committee/s thereof.

- 6. Comparative remuneration profile with respect to industry, size of the Company, profile of the position and person: The executive remuneration in the industry is on the rise. Appreciating this, the approval is granted by the Board of Directors, for the proposed remuneration after perusing the remuneration of managerial persons in the Specialty Chemical Industry and other companies comparable with the size of the Company, industry benchmarks in general, profile and responsibilities of Ms. Meher Vakil as the Managing Director of the Company.
- 7. Pecuniary relationship directly or indirectly with the Company or relationship with the managerial personnel, if any: Besides the remuneration proposed to be paid to Ms. Meher Vakil and 145000 (1.95%) equity shares of the Company, she does not have any other pecuniary relationship with the Company. Ms. Meher Vakil is the Daughter of Mrs. Shernaz Vakil currently designated as Chairperson & Managing Director of the Company.
- **8. Other Terms:** Ms. Meher Vakil's office as Director will be subject to determination by retirement by rotation and the same will not impact the continuity of her tenure as Managing Director.

III. Other information:

Reasons of loss or inadequate profits, Steps taken or proposed to be taken for improvement and expected increase in productivity and profits in measurable terms:

Our company in the past few years had been through various adverse situations such as labour unrest, shift of production facilities from Pune to Dahej, Covid, fire incident, which resulted in operational loss in the past few years.

The fire incident disrupted the production capacity of the manufacturing unit. For some months the company had to resort to job work manufacturing to keep up with customer demand. Subsequently the company set up Phase I plant which can cater to immediate customer requirements in 2021-22 and in 2022-23 have set up Phase II plant which has enabled the company to regain its lost capacities due to fire and the Company has regained its profitability in current financial year.

The Board recommends the Special Resolution set forth at Item No. 2 of the Notice for approval of the members.
